The proposed density of houses and multitude of accesses which would cut across the green verge, would fail to preserve these features.

The scheme would probably lead to harm to the character and appearance of the Area and not comply with the guidance of the Conservation Area Appraisal, the NPPF and legal requirement of Section 27 of the Planning (Listed Buildings and Conservation Areas) Act 1990.
